Soil Salinity Threatens Agricultural Activities in Kano River Irrigation Project ...Experts

Bayero University in collaboration with ICRISAT and NARSDA organizes an inception workshop to commence the 'action research' to tackle salinity/solidity problem in Kano River Irrigation Project (KRIP). It may be recalled that recently BUK won about a hundred million research grant from TRIMING (Transforming Irrigation Management in Nigeria), World Bank counter fund project under Federal Ministry of water resources, Nigeria. During the sensitization/inception workshop, experts, government agencies, farmers and all stake holders participated and deliberated on the way forward on how to pull synergy to address the problem of salinity in KRIP.

In his keynote address the representative of the National

Project Coordinator (NPC) of TRIMING, Malam Hallai Garba, has said about 40 percent of the total agricultural produce is loss yearly per hectare by farmers in the Kano River Irrigation Project due to the emergence of soil salinity and solidity in the region.

Speaking at the declaration of the project commencement of an action research sensitization workshop on Participatory Soil Salinity/Sodicity Management for Sustainable Irrigated Crop Productivity and Improved Livelihood in Kano River Irrigation Project for farmers drawn from Kura, Garun Malam, and Bunkure Local Government Areas on Thursday, 23rd May, 2019 in Kura town, said this problem has the tendency of threatening agricultural activities in the region.

Malam Garba, said the research project jointly undertaken by the BUK (Lead Institute), ICRISAT and National Space and Research Development Agency (NASRDA) aimed at identifying the cause of the salinity and sodicity as well as proffering possible ways of tackling the menace.

According to him, following the emergence of this problem, farmers in the Kano River Irrigation Project (KRIP) have been experiencing reduction in output of between 30-40 percent of their total produce, hence the urgent need to put heads together in order to address it on time.

“The issue of soil salinity/sodicity is a major threat to agricultural activities in the region. A farmer lost between 30-40 percent of his output per hectare, this is a very serious threat which requires urgent solution to address it,” he declared.

Explaining the concept of the research, the Principal Investigator/Lead Researcher for the Transforming Irrigated Management in Nigeria (TRIMING Project), Professor Abdu Ahmed Manga of the Department of Agronomy, Faculty of Agriculture, Bayero University told the participants that following complain by the farmers, the Federal Government through the Ministry of Water Resources commissioned BUK, ICRISAT and NASRDA to conduct a participatory research on how best to tackle the menace.

He said the project which is for a period of three years and will involve assessment of saline/sodic soils remediation

and amelioration, evaluating productivity, profitability and uptake of the salinity/sodicity remediation and amelioration by farmers as well as piloting new rice and tomato varieties tolerant to prevailing biophysical stresses. It will also promote integrated soil fertility management practices and developing mechanisms for making farmers to manage irrigation and drainage more effectively with a view to preventing the development of soil salinity.

The research team will also delineate the affected areas out of the over 22,000 developed hectares under the Kano River Irrigation Project. Saying, unlike the previous research project, TRIMING will be a participatory with the farmers and all the stakeholders for an authentic result.

Also explaining further, the Research Team Coordinator, Dr. Mohammed Maina of the Department of Agric and Environmental Engineering of Bayero University said the research will equally explore the effect of the ground water rise, water quality and use of chemical fertilizer on salinity build up.

The workshop had in attendance representatives of the project partners of BUK, ICRISAT and NASRDA, the research panel of experts. Also the representatives of the Managing Director of Hadejia Jama'are River Development Authority and KNARDA as well as representatives of the District Heads and Council Chairmen of Kura, Bunkure and Garun Malam , most importantly the farmers and sectoral leaders and their members respectively.

Teaching Qur'anic Solutions to Societal Problems – Prof Maiwada

The Centre for Quranic Studies has organized a one-day workshop on the importance of the teachings of Holy Quran in our day to day activities with a view to addressing the social problems facing the society.

Professor Danjuma A. Maiwada, who was the keynote

speaker on a topic titled: “Teaching of Holy Quran and the evidence of the existence of Allah”, cited examples from the miracle of embryonic development mentioned in the Qur'an in such minute detail much of which was unknown to scientists until recently.

He mentioned the first stages of life after conception and the witnesses of scientists about these scientific facts of the Quran.

Professor Maiwada said God mentioned about the stages of man's embryonic development in which he says “We created man from an extract of clay then We made him as a drop in a place of settlement, firmly fixed. Then we made the drop into an alaqah cleech, suspended thing, and blood clot), then We made the adaqah into mudghah (chewed substance)”. (Quran 23:12-14).

Prophet Muhammad (may the mercy and blessings of God be upon him), have known this 1400yrs ago, but scientists had only recently discovered this using advanced equipment and powerful microscopes, which did not exist at that time?” he further remarked.

Professor Maiwada added that Hamm and Leeuwen-hock were the first scientists to observe human sperm cells (spermatozoa) using an improved microscope in 1977 (more than 1000 years after Muhammad).

The Director, Centre for Quranic Studies, Dr. Muhammad Babangida Muhammad, who served as the Chairman of the occasion, said Islam was revealed to

mankind with the intention of presenting a peaceful life where the infinite compassion and mercy of God manifested on Earth.

He said God called all people to live by the moral values He set, so that compassion, mercy, peace and love could be experienced all over the world, but “what we are seeing

today in many Muslim societies does not reflect the teachings of the Qur'an and so we need to adjust our activities in order to meet or match the values of the Quran, which holds Muslims accountable for treating other people kindly irrespective of whether they are Muslims or non-Muslims”.

CDA Organizes Orientation for New Students

The Director told the new students that CDA had been organizing short courses by inviting resource persons from within and outside the country in order to prepare students to be relevant and excellent in their various specializations.

He said the centre's supported programmes in Natural Resource Management and Climate Change were recently selected to be among the only seven in Africa for Partnership for Skills in Applied Sciences, Engineering and Technology (PASET's) Pan African Regional Scholarship and Innovation Fund (RSIF) PhD programmes in which 144 applications were received and reviewed by independent reviewers.
